

ORDINANCE NO. 95-22

AN ORDINANCE AMENDING SECTION 3 OF ORDINANCE NO. 94-19 ESTABLISHING RATES FOR THE COLLECTION OF GARBAGE AND REFUSE TO BE CHARGED BY THE CITY OF COMMERCE, TEXAS, TO PATRONS FOR GARBAGE COLLECTION SERVICES; PROVIDING A SAVINGS CLAUSE, DECLARING AN EMERGENCY, REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith AND ESTABLISHING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY OF COMMERCE:

SECTION 1. AMENDMENT:

Section 3, Exhibit "B" of Ordinance 94-19 is hereby amended so that said section shall hereafter read as follows: See Exhibit "B" attached.

SECTION 4. Ordinances or parts of ordinances inconsistent with or in conflict with the provisions of this ordinance shall be and the same are hereby expressly repealed.

SECTION 5. If any section, sub-section, word, sentence, or phrase of this ordinance is declared to be invalid, it shall not effect the validity of this ordinance.

SECTION 6. It is hereby found and determined that the meeting at which this ordinance was passed was open to the public as required by Texas law, and that advance public notice of the time, place and purpose of said meeting was given.

SECTION 7. Whereas an emergency is apparent for the immediate preservation of order, health, safety and general welfare of the public, all rules and regulations requiring the reading of Ordinance more than one time and on more than one occasion are hereby suspended.

SECTION 8. EFFECTIVE DATE:

The effective date of the new sanitation rates will be as of December 1, 1995.

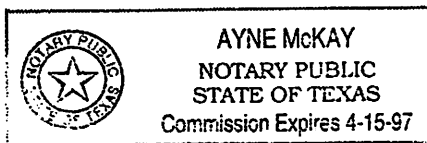
