

ORDINANCE NO 95-23

AN ORDINANCE OF THE CITY OF COMMERCE, COMMERCE, TEXAS PROVIDING THAT A PORTION OF NORTH NEAL STREET BE RENAMED - SAID PORTION BEING NAMED BEAU AUSTIN STREET, CONTAINING A REPEALING CLAUSE, A SAVINGS CLAUSE, PROVIDING AN EFFECTIVE DATE, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY OF COMMERCE, TEXAS:

SECTION I.

WHEREAS, a request has been made by a homeowner who lives on North Neal Street, off of Highway 71 in an area known as the "Cornerpost of Commerce",

SECTION II.

WHEREAS, said homeowner has come before the City Council to request that the portion of the street on which he and his family live be renamed from North Neal Street to Beau Austin Street; Beau Austin being name of child of said homeowner, Brett Bennett,

SECTION III.

WHEREAS, after careful consideration by members of the City Council it has been deemed to be in the best interest and general welfare of the City of Commerce to rename the portion of North Neal Street on which Brett Bennett and his family live; name of said portion of street being changed from this day henceforth to be "Beau Austin Street" in Commerce, Texas, as shown in Exhibit "A" and made a part hereof as if copied herein verbatim.

SECTION IV.

WHEREAS, All ordinances or parts of Ordinances inconsistent with or in conflict with the provisions of this Ordinance shall be and the same are hereby expressly repealed.

SECTION V.

WHEREAS, If any section, sub-section, word, sentence, or phrase of this Ordinance is declared to be invalid, it shall not affect the validity of this Ordinance.

SECTION VI.

WHEREAS, an emergency is apparent for the immediate preservation of order, health, safety and general welfare of the public, all rules and regulations requiring the reading of ordinances more than one time and on more than one occasion are hereby suspended.

SECTION VII.

This Ordinance shall take effect and be in force from and after its passage and approval.

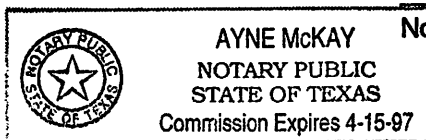

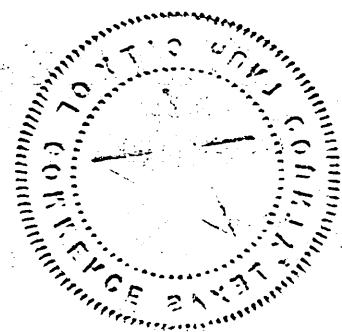

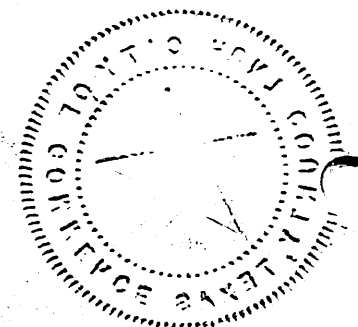
