

ORDINANCE NO. 97-5

AN ORDINANCE OF THE CITY OF COMMERCE, TEXAS, PROVIDING THAT THE CODE OF ORDINANCES OF THE CITY OF COMMERCE BE AMENDED BY REVISING THE TRAFFIC CONTROL MAP ADOPTED IN PARAGRAPH (B) OF SECTION 26-72 OF SAID CODE; AMENDING THE PLACEMENT OF TRAFFIC CONTROL DEVICES; PROVIDING FOR A PENALTY NOT TO EXCEED \$200.00; PROVIDING A SAVINGS CLAUSE; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith; DECLARING AN EMERGENCY AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY OF COMMERCE, TEXAS:

SECTION I: WHEREAS, that the Traffic Control Devices Map adopted in Paragraph (B) of Section 26-72 of the Code of Ordinances of the City of Commerce, Texas, be amended to locate stop signs at Maple and Park Street same being reflected on the plat attached hereto marked Exhibit "A", and made a part hereof as if copied herein verbatim;

SECTION II: WHEREAS, any person violating any of the provisions of this ordinance shall be guilty of a Class "C" misdemeanor, and upon conviction shall be fined in any sum not to exceed \$200.00.

SECTION III: WHEREAS, all ordinances or parts of ordinances in conflict herewith are hereby expressly repealed.

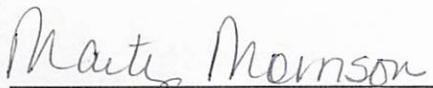
SECTION IV: WHEREAS, if any section, sub-section, word, sentence, or phrase of this ordinance is declared to be invalid, it shall not effect the validity of this Ordinance.

SECTION V: WHEREAS, this Ordinance is declared to be an emergency measure, necessary for the preservation of the health, safety, and welfare of the City of Commerce, Texas, and the inhabitants thereof; therefore, all rules and regulations providing for the reading of ordinances more than one time or on more than one occasion be and the same are hereby suspended, and this Ordinance is passed and shall take effect as an emergency measure, and shall be and remain in full force and effect as herein provided from and after its passage and approval.

SECTION VI: NOW, THEREFORE, this Ordinance shall take effect and be in force 30 days from and after its passage and approval.

PASSED AND APPROVED at a regular meeting of the City Council of the City of Commerce, Texas, on this the 4th day of March, 1997.

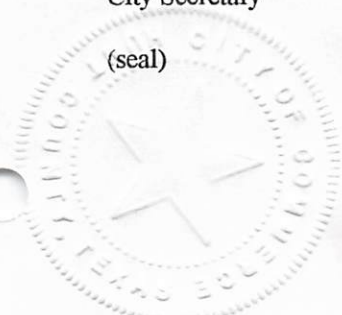
