

ORDINANCE 00-12

AN ORDINANCE OF THE CITY OF COMMERCE, TEXAS, PROVIDING THAT THE CODE OF ORDINANCES OF THE CITY OF COMMERCE BE AMENDED BY REVISING THE TRAFFIC NO-PARKING MAP ADOPTED IN PARAGRAPH 3 OF SECTION 25-112 OF SAID CODE; PROVIDING FOR A PENALTY NOT TO EXCEED \$200.00; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; CONTAINING A SAVINGS CLAUSE AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY OF COMMERCE, TEXAS:

Section I.

Whereas, that the Traffic No-Parking Map adopted in Paragraph 3 of Section 25-112 of the Code of Ordinances of the City of Commerce, Texas, be amended to include the following No-Parking Area:

Designate a No-Parking Zone along the South side of Aldridge Street, beginning at the intersection of Aldridge and Mangum and going East to the intersection of Aldridge and Solomon; along the West side of Solomon, beginning at the intersection of Culver and Solomon and continuing North to Aldridge Street and Solomon Drive; along the North side of Enlow Circle, beginning at the intersection of Enlow Circle and Solomon Drive and continuing to the West along curb line to the fire hydrant then from the intersection of Aldridge and Enlow Circle continuing South along West curb to the cul-de-sac until which time the new street is constructed and named according to the proposed grant.

Section II:

Any person violating any of the provisions of this ordinance shall be guilty of a Class "C" misdemeanor, and upon conviction shall be fined in any sum not to exceed \$200.00.

Section III:

All ordinances or parts of ordinances in conflict herewith are hereby expressly repealed.

Section IV:

If any section, sub-section, word, sentence, or phrase of this ordinance is declared to be invalid, it shall not effect the validity of this ordinance.

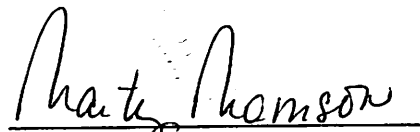
Section V:

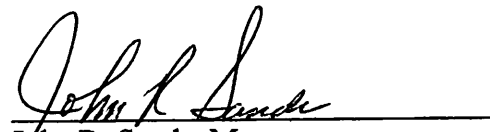
PASSED AND APPROVED on its **SECOND READING** at a regular meeting of the City Council of the City of Commerce, Texas on this the 19th day of September 2000.

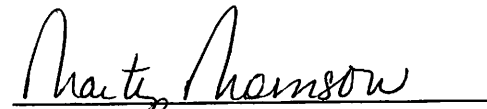

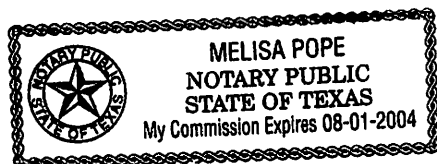

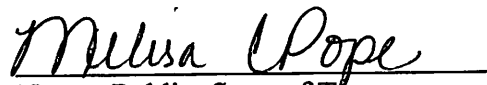
