

ORDINANCE NO. 01-08

AMENDED BY ORDINANCE 01-17

AN ORDINANCE OF THE CITY OF COMMERCE, COMMERCE, TEXAS, CREATING A BEAUTIFICATION COMMISSION; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE CITY OF COMMERCE, TEXAS:

WHEREAS, the City Council of the City of Commerce hereby creates a Beautification Commission, which shall be composed of thirteen member and four alternates as follows:

1. Thirteen representatives of the public at large: 7-two yr term/ 6 one yr term
2. Four alternate members: 2 two yr term/2 one yr term

(a) The members of the beautification commission and their successors shall be appointed by the council for two-year terms or until their successors are appointed. All vacancies shall be filled for the unexpired term in the same manner as provided for the original appointments. Terms shall be staggered. The members of the commission shall serve without compensation and must be residents of the city.

(b) The purpose of the beautification program is to make the City a clean and attractive City in which to live, to maintain a healthy environment, to educate the City's citizens as to the ongoing process of keeping their City beautiful, and to generally beautify the City.

(c) The Commission considers the following aspects of a potential beautification program and makes recommendations to the City Council: landscaping of City rights-of-way and City property; award programs for businesses and residential areas that beautify their surroundings through landscaping, maintenance, the abatement of litter or other methods; voluntary recycling, including the promotion and education of the need for recycling; the possibility of joining state or nationwide groups that are focused on beautification; and how to involve the general public, the school system, the business community and residents and property owners in a beautification program.

WHEREAS, that all ordinances or parts of ordinances in conflict herewith are repealed.

WHEREAS, if any section, article, paragraph, application, clause, phrase or word in this ordinance or application thereto any person or circumstances is held invalid or unconstitutional by a Court of competent jurisdiction, such holding shall not effect the validity of the remaining portions of the ordinance; and the City Council hereby declares it would have passed such remaining portions of the ordinance despite such invalidity, which remaining portions shall remain in full force and effect.

WHEREAS this ordinance shall become effective upon its passage and approval.

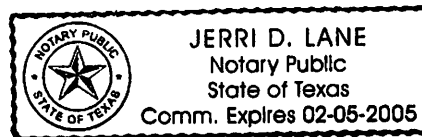
