

ORDINANCE 01-35

AN ORDINANCE AMENDING SECTION 5 OF THE GARBAGE AND REFUSE ORDINANCE TITLED COLLECTION OF FEES; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCE IN CONFLICT HEREWITH; PROVIDING A SAVINGS CLAUSE AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY OF COMMERCE, TEXAS

SECTION 1.

Section 5 of the Garbage and Refuse Ordinance for the City of Commerce shall hereinafter read as follows:

COLLECTION FEES:

The collection and removal of garbage and waste in approved containers from premises used for residential purposes, shall be made two times each week; the number of bags, bundles and containers in total not to exceed ten (10) at each time. From premises used for commercial, business, and industrial purposes, in accordance with customers' demands, the contractor to evaluate the amount and frequency of pickup. The fair and reasonable charges for such services are hereby determined and marked Exhibit "A" and made a part hereof as if copied herein verbatim.

If required by customer, special collection of dead animals, non-standard waste, and/or special waste shall be provided by the contractor at a price consistent with industry price.

SECTION 2.

All ordinances and parts of ordinances inconsistent with or in conflict with the provisions of this ordinance shall be and the same are hereby expressly repealed.

SECTION 3.

In any section, sub-section, word, sentence, or phrase of this ordinance is declared to be invalid, it shall not affect the validity of this ordinance.

SECTION 4.

This Ordinance shall take effect and be in force December 1, 2001.

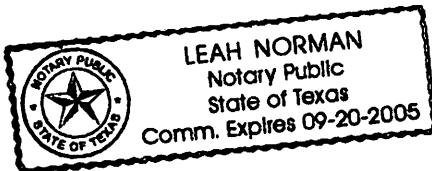
