

ORDINANCE NO. 02-13

AN ORDINANCE OF THE CITY OF COMMERCE, TEXAS, PROVIDING THAT THE CODE OF ORDINANCES OF THE CITY OF COMMERCE BE AMENDED BY REVISING THE TRAFFIC CONTROL MAP ADOPTED IN PARAGRAPH (B) OF SECTION 26-72 OF SAID CODE; AMENDING THE PLACEMENT OF TRAFFIC CONTROL DEVICES; PROVIDING FOR A PENALTY NOT TO EXCEED \$200.00; PROVIDING A SAVINGS CLAUSE; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH;

BE IT ORDAINED BY THE CITY OF COMMERCE, TEXAS:

SECTION I: A new extension of roadway has been added around the AC Williams Elementary School. This roadway is an extension of Washington Street as is hereby officially being named as a continuation of Washington Street.

SECTION II. A school zone is hereby designated from the existing school zone south on the new extension of Washington Street and west to the intersection of the southern most section of Monroe Street.

SECTION III. That the Traffic Control Devices Map adopted in Paragraph (B) of Section 26-72 of the Code of Ordinances of the City of Commerce, Texas, be amended to locate a three way stop sign at the intersection of Monroe and Charity and Washington Streets, same being reflected on the plat attached hereto marked Exhibit "A", and made a part hereof as if copied herein verbatim;

SECTION IV: any person violating any of the provisions of this ordinance shall be guilty of a Class "C" misdemeanor, and upon conviction shall be fined in any sum not to exceed \$200.00.

SECTION V: all ordinances or parts of ordinances in conflict herewith are hereby expressly repealed.

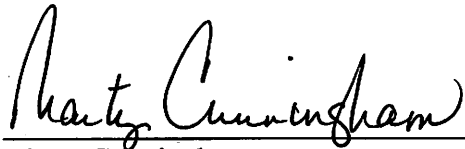
SECTION VI: if any section, sub-section, word, sentence, or phrase of this ordinance is declared to be invalid, it shall not affect the validity of this Ordinance.

SECTION VII: NOW, THEREFORE, this Ordinance shall take effect and be in force 30 days from and after its passage and approval.

PASSED AND APPROVED at a regular meeting of the City Council of the City of Commerce, Texas on this the 20th day of August 2002.

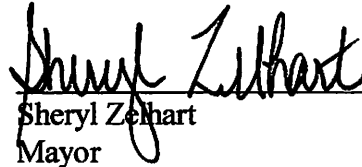
