

ORDINANCE 03-13

AN ORDINANCE OF THE CITY OF COMMERCE, TEXAS, PROVIDING THAT THE CODE OF ORDINANCES OF THE CITY OF COMMERCE BE AMENDED BY REVISING THE TRAFFIC NO-PARKING MAP ADOPTED IN PARAGRAPH 3 OF SECTION 25-112 OF SAID CODE; ALSO DESIGNATING RATES OF SPEED AND THE PLACEMENT OF STOP SIGNS; PROVIDING FOR A PENALTY NOT TO EXCEED \$200.00; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; CONTAINING A SAVINGS CLAUSE AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY OF COMMERCE, TEXAS:

Section I.

Whereas, that the Traffic No-Parking Map adopted in Paragraph 3 of Section 25-112 of the Code of Ordinance of the City of Commerce, Texas, be amended to include the following No-Parking Area:

Designate no-parking along the North Side of Roseanne Circle, beginning at the cul-de-sac of Enlow Circle and continuing west to the point the curb line turns north. Also along Roseanne Circle on the wet curb beginning at the southern most point and continuing to where the cul-de-sac begins at the northern end of Roseanne Circle. Also beginning at the northwest corner of the intersection of Aldridge and Enlow Circle and continuing north along the west curb to the point that the curb ends. Also along the east curb of Roseanne Dr. from the intersection of Knight St. to the Intersection of Aldridge.

Section II.

Whereas, in addition the Traffic Control Map be amended to place stop signs in the following locations:

- On Knight Street at the intersection of Knight & Mangum.
- On Roseanne Dr. at the intersection of Roseanne and Knight, and at Roseanne and Aldridge.
- On Enlow Circle at the intersection of Enlow Circle and Roseanne Dr. and Enlow Circle and Aldridge.
- At the intersection of Enlow Circle and Roseanne Circle.

Section III.

Whereas, further amendment to said Code of Ordinances will establish a prudent rate of speed along the streets of Roseanne Dr., Roseanne Circle, Enlow Circle, Aldridge will be set at a rate of 20 mph.

Section IV:

Any person violating any of the provisions of this ordinance shall be guilty of a Class "C" misdemeanor, and upon conviction shall be fined in any sum not to exceed \$200.00.

Section V:

All ordinances or parts of ordinances in conflict herewith are hereby expressly repealed.

Section VI:

If any section, sub-section, word, sentence, or phrase of this ordinance is declared to be invalid, it shall not effect the validity of this ordinance.

Section VII:

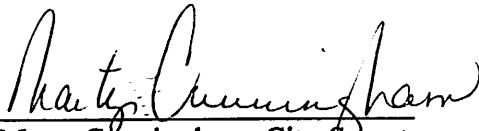
This Ordinance shall take effect and be in force from and after its passage and approval.
