

ORDINANCE 04-14

AN ORDINANCE AMENDING EXHIBIT "A" OF SECTION 78.5 OF THE GARBAGE AND REFUSE ORDINANCE TITLED COLLECTION OF FEES; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCE IN CONFLICT HEREWITH; PROVIDING A SAVINGS CLAUSE AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY OF COMMERCE, TEXAS

SECTION 1.

Exhibit "A" of Section 78-5 of the Garbage and Refuse Ordinance for the City of Commerce shall hereinafter read as follows:

In any section, sub-section, word, sentence, or phrase of this ordinance is declared to be invalid, it shall not affect the validity of this ordinance.

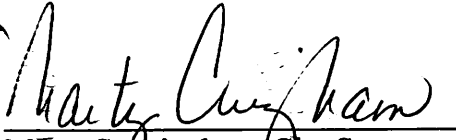
SECTION 4.

This Ordinance shall take effect and be in force upon approval.

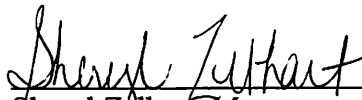
