

ORDINANCE 07-09

AN ORDINANCE AMENDING THE TRAFFIC CONTROL MAP ESTABLISHING REGULATIONS AND RESTRICTIONS FOR THRU TRUCK TRAFFIC ON NORTH NEAL STREET; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith; FIXING PENALTIES FOR VIOLATION HEREOF; PROVIDING A SAVINGS CLAUSE AND DECLARING AN EMERGENCY.

WHEREAS, a regular meeting of the City Council of the City of Commerce, Texas, was held in Commerce, Texas, at City Hall, on the 4th day of September 2007, at 7:00 p.m., a majority of council members being present and constituting a quorum, the following ordinance was adopted:

WHEREAS, due to the recent location of Legacy Homes, a mobile home manufacturing plant, the City Council hereby amends the traffic control ordinance to regulate and restrict thru truck traffic along N. Neal Street.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COMMERCE

I.

Truck/home traffic is hereby restricted to trucks/homes of Legacy Homes only.

II.

Truck/home traffic will be prohibited between the hours of 7:00 a.m. and 8:00 a.m. and between the hours of 3:00 p.m. and 4:15 p.m. during days in which the Commerce Independent School District holds classes. At no time will two (2) truck/homes be allowed on N. Neal Street without a 10 minute gap/lapse of time.

III.

Truck/home traffic will be limited to the finished home or the half unit only.

IV.

All other truck traffic to and from Legacy Homes including delivery of supplies will be restricted to alternate routes and will be prohibited.

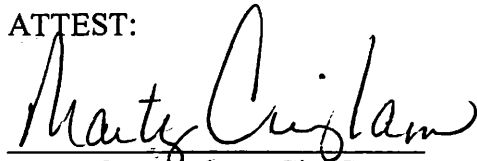
WHEREAS, all ordinances and parts of ordinances in force in the City of Commerce, Texas, which conflict with the terms and provisions of this ordinance are hereby repealed insofar as they conflict with this ordinance, but all other portions of said ordinance shall remain in full force and effect.

WHEREAS, any person violating the provisions of this ordinance shall be guilty of a misdemeanor and upon conviction thereof shall be punished by a fine not exceeding TWO HUNDRED AND NO/100 (\$200.00) DOLLARS.

WHEREAS, this Ordinance shall take effect and be in force from and after its passage and approval.

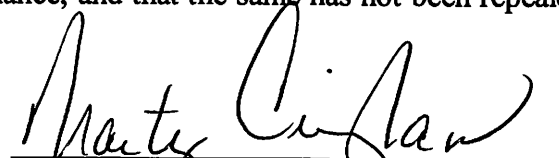

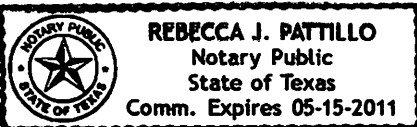

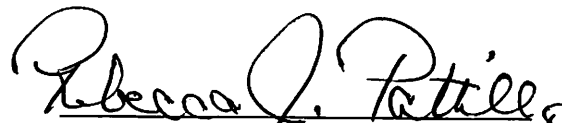
