

ORDINANCE NO. 08-07

AN ORDINANCE OF THE CITY OF COMMERCE, TEXAS, APPROPRIATING FUNDS TO PAY FOR THE SALARY OF THE INTERIM CITY MANAGER; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; CONTAINING A SAVINGS CLAUSE; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY OF COMMERCE, TEXAS:

WHEREAS, the City of Commerce will be appropriating funds in the amount of \$5,169.71 into department 112 to pay for Interim City Manager's salary; and

WHEREAS, after careful consideration, the City Council of the City of Commerce deems it in the best interest and general welfare of the City that there be appropriated \$5,169.71 from the Reserves into Fund 112-1001.

NOW THEREFORE BE IT ORDAINED, and it is hereby ordained that there be appropriated \$5,169.71 for the Interim City Manager's Salary.

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances in conflict herewith are hereby expressly repealed.

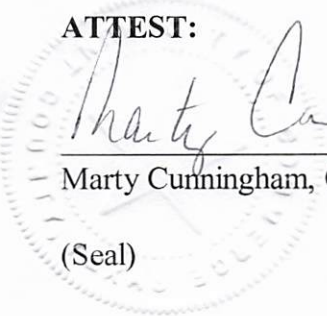
SECTION 1. If any section, subsection, word, sentence, or phrase of this ordinance is declared to be invalid it shall not effect the validity of this ordinance.

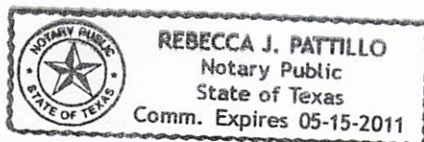

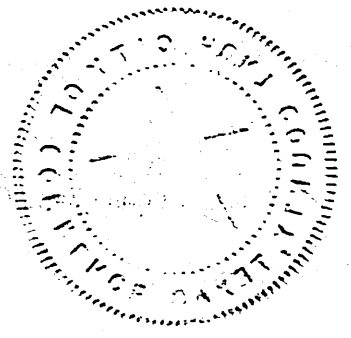

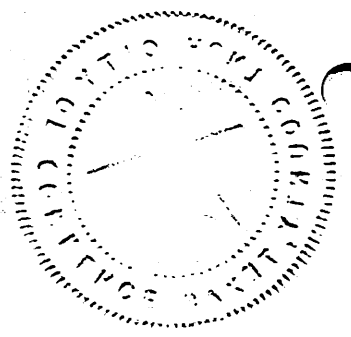
