

ORDINANCE NO. 11-13

AN ORDINANCE OF THE CITY OF COMMERCE, COMMERCE, TEXAS, PROVIDING THAT THE CODE OF ORDINANCE OF THE CITY OF COMMERCE BE AMENDED BY AMENDING SECTION II OF ORDINANCE NUMBER 02-13 OF THE CITY OF COMMERCE, TEXAS; PROVIDING A SAVINGS CLAUSE AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith.

WHEREAS, the City of Commerce, Texas heretofore on the 20th day of August, 2002 adopted Ordinance No. 02-13 which, among other things, designated in Section II a school zone for the then existing school zone South along the new extension of Washington Street and West to the intersection with the southernmost section of Monroe Street; and

WHEREAS, at the request of CISD Officials, the City of Commerce City Council hereby amends Section II of Ordinance 02-13 to read as follows:

SECTION II: A school zone is hereby designated from Charity Road south on Washington Street and west to the intersection of the southernmost section of Monroe Street.

WHEREAS, in addition to the designation of a school zone, Council hereby amends said Traffic Control Ordinance as follows:

Stop signs for Charity Road traffic be removed and the intersection of Charity Road and Washington Street.

Stop signs on Monroe Street (southbound) at Charity and Washington be removed along with stop signs on Charity Road (eastbound) at same intersection.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF COMMERCE, TEXAS:

Section II of Ordinance 02-13 of the Code of Ordinances of the City of commerce, Texas is hereby amended.

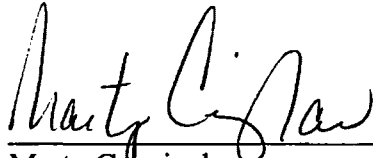
All Ordinances and parts of ordinances inconsistent with or in conflict with the provisions of this Ordinance shall be and the same are hereby expressly repealed.

PASSED AND APPROVED on the second reading at a regular meeting of the City Council of the City of Commerce, Texas on this the 18th day of October 2011.

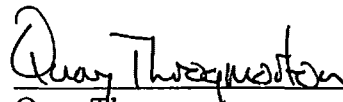
