

ORDINANCE 13-16

AN ORDINANCE AMENDING EXHIBIT "A" OF SECTION 78.5 OF THE GARBAGE AND REFUSE ORDINANCE TITLED COLLECTION OF FEES; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCE IN CONFLICT HEREWITH; PROVIDING A SAVINGS CLAUSE AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY OF COMMERCE, TEXAS

SECTION 1.

Exhibit "A" of Section 78-5 of the Garbage and Refuse Ordinance for the City of Commerce shall hereinafter read as follows:

In any section, sub-section, word, sentence, or phrase of this ordinance is declared to be invalid, it shall not affect the validity of this ordinance.

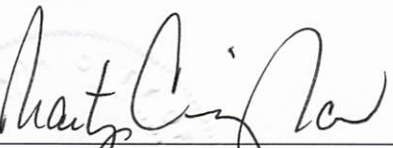
SECTION 4.

PASSED AND APPROVED on the second reading at a regular meeting of the City Council of the City of Commerce, Texas on this the 17th day of September 2013.

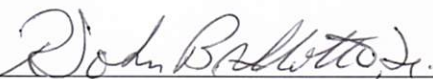

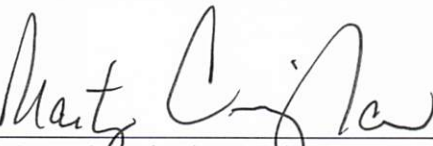

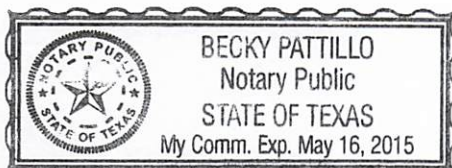
