

ORDINANCE NO. 15-13

AN ORDINANCE OF THE CITY OF COMMERCE, COMMERCE, TEXAS, AMENDING ORDINANCE 15-05 BY APPROPRIATING ADDITIONAL FUNDS AND REDIRECTING THE USE OF SAID FUNDS FOR PHASE ONE OF FARMERS MARKET IMPROVEMENT PROJECT TO INCLUDE INSTALATION OF DIGITAL DISPLAY SIGNS AND THE EXPANSION OF THE FARMER'S MARKET PAVILION; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith; DELCARING AN EMERGENCY AND CONTAINING A SAVINGS CLAUSE.

BE IT ORDAINED BY THE CITY OF COMMERCE, TEXAS:

WHEREAS, City of Commerce authorized the appropriation of funds not to exceed \$50,000 for Phase One of the Farmer's Market Improvement Project; and

WHEREAS, the City now so desires to increase the appropriation in an amount not to exceed \$1.00 to include the installation of digital display signs and the expansion of the Farmer's Market Pavilion.

WHEREAS, after careful consideration, the City Council of the City of Commerce deems it in the best interest and general welfare of the City that there be appropriated an additional \$1.00 into Fund 140-6200; and

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances in conflict herewith are hereby expressly repealed.

SECTION 1. If any section, subsection, word, sentence, or phrase of this ordinance is declared to be invalid it shall not affect the validity of this ordinance.

SECTION 2. That an emergency exists necessitating the suspension of any rule requiring multiple readings of this Ordinance and all multiple readings of this Ordinance are hereby waived; this Ordinance shall take effect immediately upon its passage.

SECTION 3. This ordinance shall take effect and be in force from now on after its passage and approval.

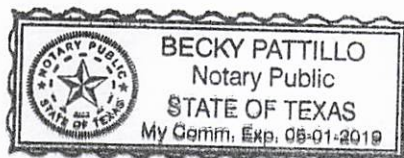
