**WHEREAS** the City of Commerce hereby supports in mind and in spirit said Program to reduce hunger in Commerce.

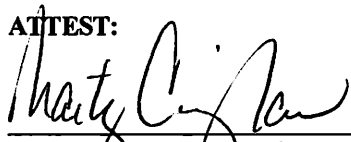

**BE IT FURTHER RESOLVED** that the City Secretary be authorized and she is hereby authorized to attest to the signature of the Mayor to this Resolution;

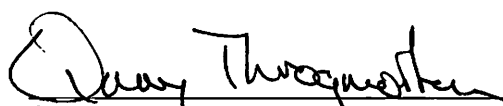
