

RESOLUTION NO. 11-38

A RESOLUTION RELATING TO BIDS RECEIVED FOR LENDING INSTITUTION FOR A LEASE/PURCHASE ON VEHICLES FOR THE CITY OF COMMERCE, AWARDED THE BID TO GUARANTY BOND BANK; ALL OTHER BIDS BEING REJECTED. GRANTING AUTHORITY TO THE MAYOR TO EXECUTE SAID RESOLUTION AND AUTHORIZING CITY SECRETARY TO AUTHENTICATE MAYOR'S SIGNATURE TO SAID RESOLUTION, AND AUTHORIZING CITY MANAGER TO EXECUTE ALL INSTRUMENTS REQUISITE IN IMPLEMENTING SAID RESOLUTION, AND AUTHORIZING CITY SECRETARY TO AUTHENTICATE CITY MANAGER'S SIGNATURE TO ANY INSTRUMENTS REQUISITE IN IMPLEMENTING THIS RESOLUTION.

A regular meeting of the City Council of the City of Commerce, Texas, was held in Commerce, Texas, at City Hall, on the 20th day of September 2011, at 6:00 p.m.; a majority of Council Member's being present and constituting a quorum, the following resolution was adopted:

WHEREAS, after review of said bids contained therein the City Council deems that the bid from Guaranty Bond Bank be accepted and is hereby accepted, and all other bids be rejected; and

BE IT RESOLVED that the Mayor of the City of Commerce, Texas, be authorized and he is hereby authorized to execute this resolution;

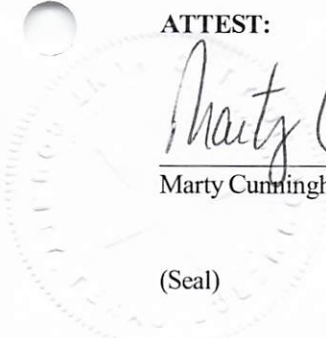
BE IT FURTHER RESOLVED that the City Secretary be authorized and she is hereby authorized to attest to the signature of the Mayor to this resolution;

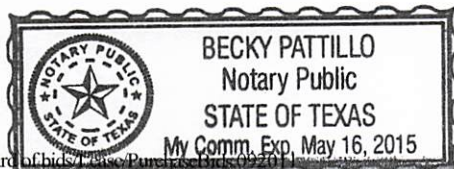
