A RESOLUTION ALLOCATING CITY OF COMMERCE'S CHOICE OF VOTE FOR MEMBER TO BE ELECTED BY BALLOT FOR THE HUNT COUNTY APPRAISAL DISTRICT BOARD OF DIRECTORS FOR TERM ENDING 2013. AUTHORIZING MAYOR TO EXECUTE SAID RESOLUTION AND AUTHORIZING CITY SECRETARY TO AUTHENTICATE MAYOR'S SIGNATURE TO SAID RESOLUTION.
