

RESOLUTION NO. 13-01

A RESOLUTION AUTHORIZING WATER AND WASTEWATER RATE INCREASE FOR TEXAS A&M UNIVERSITY-COMMERCE; GRANTING AUTHORITY TO THE MAYOR TO EXECUTE SAID RESOLUTION AND AUTHORIZING CITY SECRETARY TO AUTHENTICATE MAYOR'S SIGNATURE TO SAID RESOLUTION, AND AUTHORIZING CITY MANAGER TO EXECUTE ALL INSTRUMENTS REQUISITE IN IMPLEMENTING SAID RESOLUTION, AND AUTHORIZING CITY SECRETARY TO AUTHENTICATE CITY MANAGER'S SIGNATURE TO THIS RESOLUTION.

A regular meeting of the City Council of the City of Commerce, Texas, was held in Commerce, Texas, at City Hall, on the 15th day of January 2013 at 6:00 p.m.; a majority of Council Member's being present and constituting a quorum, the following Resolution was adopted:

WHEREAS, On January 8, 2010 the City of Commerce entered into a five year water and wastewater contract with Texas A&M University-Commerce with rate adjustments to be provided annually; and

WHEREAS, according to a rate study performed by Bob McLain the annual rates shall be adjusted annually, and;

WHEREAS, rates for 2013 shall be as follows:

\$5.25 per 1,000 gallons of water

\$4.56 per 1,000 gallons of sewer collection and treatment;

NEW METER RATES:

.750 inch	\$12.50
1.00 inch	\$31.25
1.50 inch	\$62.50
2.00 inch	\$100.00
3.00 inch	\$200.00
4.00 inch	\$312.50
6.00 inch	\$625.00
8.00 inch	\$1,000.00
10.0 inch	\$1,437.50

WHEREAS, said rates shall take effect in February 1, 2013.

NOW, THEREFORE, BE IT RESOLVED that the Mayor of the City of Commerce, Texas, be authorized and he is hereby authorized to execute this Resolution;

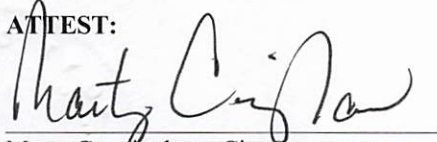
BE IT FURTHER RESOLVED that the City Secretary be authorized and she is hereby authorized to attest to the signature of the Mayor to this Resolution;

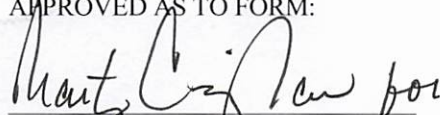

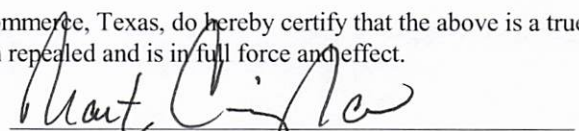

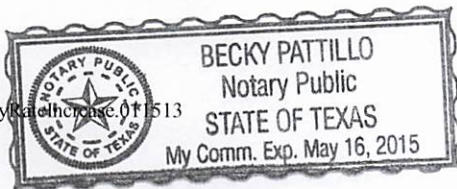
