

RESOLUTION NO. 15-19

A RESOLUTION AUTHORIZING ACCEPTANCE AND ADOPTION OF THE HUNT COUNTY HAZARD MITIGATION ACTION PLAN, JUNE 2015; GRANTING AUTHORITY TO THE MAYOR TO EXECUTE SAID RESOLUTION AND AUTHORIZING CITY SECRETARY TO AUTHENTICATE MAYOR'S SIGNATURE TO SAID RESOLUTION, AND AUTHORIZING CITY MANAGER TO EXECUTE ALL INSTRUMENTS REQUISITE IN IMPLEMENTING SAID RESOLUTION, AND AUTHORIZING CITY SECRETARY TO AUTHENTICATE CITY MANAGER'S SIGNATURE TO THIS RESOLUTION.

A regular meeting of the City Council of the City of Commerce, Texas, was held in Commerce, Texas, at City Hall, on the 21st day of July 2015, at 6:00 p.m.; a majority of Council Member's being present and constituting a quorum, the following Resolution was adopted:

WHEREAS, The City of Commerce recognizes the threat that natural hazards pose to people and property within the City of Commerce; and

WHEREAS, the City of Commerce has prepared a multi-hazard mitigation plan, hereby known as Hunt County Hazard Mitigation Action Plan, June 2015 in accordance with the Disaster Mitigation Act of 2000; and

WHEREAS, Hunt County Hazard Mitigation Action Plan, June 2015 identifies mitigation goals and actions to reduce or eliminate long-term risk to people and property in the City of Commerce from the impacts of future hazards and disasters; and

WHEREAS, adoption by the City of Commerce demonstrates their commitment to the hazard mitigation and achieving the goals outlined in the Hunt County Hazard Mitigation Action Plan, June 2015.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF COMMERCE, TEXAS that:

Section 1. In accordance with City of Commerce Code of Ordinances the City of Commerce adopts the Hunt County Hazard Mitigation Action Plan, June 2015.

NOW, THEREFORE, BE IT RESOLVED that the Mayor of the City of Commerce, Texas, be authorized and he is hereby authorized to execute this Resolution;

BE IT FURTHER RESOLVED that the City Secretary be authorized and she is hereby authorized to attest to the signature of the Mayor to this Resolution;

BE IT FURTHER RESOLVED that the City Secretary be authorized and she is hereby authorized to attest to the signature of the City Manager to any and all instruments requisite to implementing this Resolution.

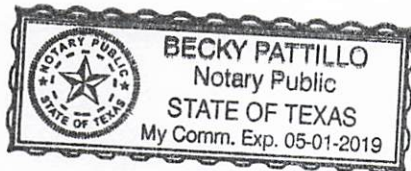
