A RESOLUTION AWARDING ADMINISTRATIVE SERVICES FOR THE TEXAS DEPARTMENT OF AGRICULTURE TXCDBG DOWNTOWN REVITALIZATION PROJECT FOR SIDEWALK IMPROVEMENTS; GRANTING AUTHORITY TO THE MAYOR TO EXECUTE SAID RESOLUTION AND ALL INSTRUMENTS REQUISITE IN IMPLEMENTING SAID RESOLUTION; AND AUTHORIZING THE CITY SECRETARY TO AUTHENTICATE MAYOR'S SIGNATURE TO THIS RESOLUTION AND ANY INSTRUMENTS REQUISITE IN IMPLEMENTING THIS RESOLUTION.

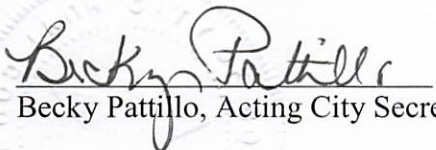
WHEREAS, after careful consideration the City Council of the City of Commerce deems it in the best interest and general welfare of the City of Commerce, to award said services to Resource Management.

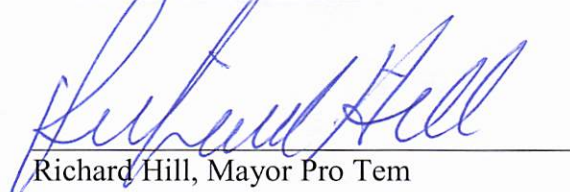
