

RESOLUTION NO. 16 - 45

A RESOLUTION BY THE COMMERCE CITY COUNCIL AUTHORIZING MITEO TO MAINTAIN COMMERCIAL OPERATIONS AT THE COMMERCE MUNICIPAL AIRPORT; AND GRANTING AUTHORITY TO THE MAYOR TO EXECUTE SAID RESOLUTION AND AUTHORIZING ACTING CITY SECRETARY TO AUTHENTICATE MAYOR'S SIGNATURE TO THIS RESOLUTION AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL INSTRUMENTS REQUISITE IN IMPLEMENTING THIS RESOLUTION AND AUTHORIZING CITY SECRETARY TO AUTHENTICATE CITY MANAGER'S SIGNATURE TO THIS RESOLUTION.

A special meeting of the City Council of the City of Commerce, Texas, was held in Commerce, Texas, at City Hall, on the 13th day of December 2016, at 6:00 p.m., a majority of council members being present and constituting a quorum, the following resolution was adopted:

WHEREAS, the City of Commerce owns and operates a general aviation airport at the Commerce Municipal Airport; and

WHEREAS, the ground leases in place at the Commerce Municipal Airport require approval for all commercial operations by the hangar tenants;

WHEREAS, Craig Johnson has requested approval for the operations of a flight school; and

WHEREAS, Craig Johnson has indicated that the flight school will purchase fuel at the airport and support other commercial operations and aviation activities at Commerce Municipal Airport;

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COMMERCE, TEXAS AS FOLLOWS:

Craig John shall be authorized to conduct a commercial flight school at the Commerce Municipal Airport, provided that such operation continues to purchase fuel and support other commercial operations and aviation activities at the Commerce Municipal Airport.

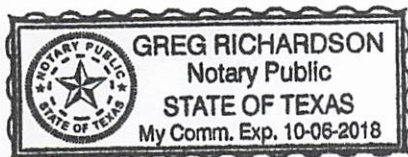

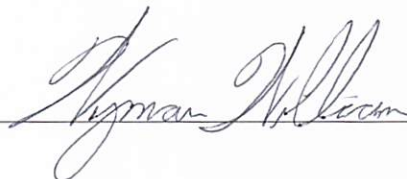

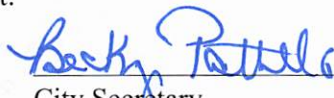
