

RESOLUTION NO. 19 - 47

A RESOLUTION ALLOCATING CITY OF COMMERCE'S CHOICE OF 154 VOTES FOR NOMINEE JOHN SANDS TO BE ELECTED BY BALLOT FOR THE HUNT COUNTY APPRAISAL DISTRICT BOARD OF DIRECTORS FOR THE 2020-2021 TERM. AUTHORIZING MAYOR TO EXECUTE SAID RESOLUTION AND AUTHORIZING CITY SECRETARY TO AUTHENTICATE MAYOR'S SIGNATURE TO SAID RESOLUTION. AUTHORIZING CITY MANAGER TO EXECUTE ANY AND ALL OTHER INSTRUMENTS REQUISITE TO IMPLEMENTING SAID RESOLUTION, AND AUTHORIZING CITY SECRETARY TO AUTHENTICATE CITY MANAGER'S SIGNATURE TO ANY AND ALL OTHER INSTRUMENTS REQUISITE TO IMPLEMENTING SAID RESOLUTION.

A regular meeting of the City Council of the City of Commerce, Texas, was held in Commerce, Texas, at City Hall on the 19th day of November 2019, at 6:00 p.m.; a majority of Council Members being present and constituting a quorum, the following resolution was adopted;

WHEREAS, with the advice and consent of the City Council, Mayor Wyman Williams nominated John Sands to the Board of Directors for the Hunt County Appraisal District in September of 2019.

WHEREAS, the City Council of the City of Commerce deems it to be in the best interest and general welfare of the City of Commerce that said vote be cast.

NOW THEREFORE, BE IT RESOLVED that the City of Commerce casts its 154 votes to nominee John Sands for the Board of Directors of Hunt County Appraisal District for the 2020-2021 term.

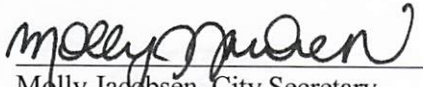
