

RESOLUTION 20 - 15

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COMMERCE, TEXAS, AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION FOR THE PUBLIC ASSISTANCE (PA) FUNDING GRANT.

WHEREAS, the City Council of the City of Commerce finds that it is in the best interest of the citizens of Commerce, Texas to seek funding assistance for costs absorbed by the City of Commerce and associated with the 2020 COVID-19 Pandemic; and

WHEREAS, certain conditions existed during this pandemic which represented a threat to the public health and safety of the citizens of Commerce, Texas and required additional supplies and personnel to manage; and

WHEREAS, it is necessary and in the best interests of the City of Commerce to apply for funding under the Public Assistance (PA) Funding Grant; and

WHEREAS, the City of Commerce and the City Council agree to provide applicable matching funds, if any, for the said project as required by the grant; and

WHEREAS, the City of Commerce agrees that in the event of loss or misuse of these funds, the City of Commerce assures funds will be returned; and

WHEREAS, the City of Commerce designates the Mayor as the grantee's authorized official whom has the power to apply for, accept, reject, alter or terminate the grant on behalf of the applicant agency;

NOW, THEREFORE, BE IT RESOLVED THAT THE COMMERCE APPROVES SUBMISSION OF THE GRANT APPLICATION FOR THE PUBLIC ASSISTANCE GRANT TO THE FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA):

BE IT FURTHER RESOLVED, that the Mayor of the City of Commerce, Texas, authorizes application for this Grant and be authorized and he is hereby authorized to execute this resolution;

BE IT FURTHER RESOLVED, that the City Secretary be authorized, and she is hereby authorized to attest to the signature of the Mayor to this resolution;

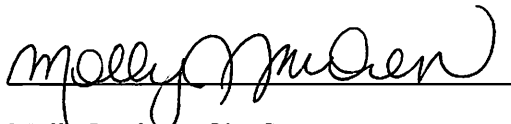
