

RESOLUTION 20 - 31

**A RESOLUTION OF THE CITY OF COMMERCE AUTHORIZING THE MAYOR TO
SELL REAL PROPERTY WITHIN THE CITY OF COMMERCE LOCATED AT 806
PLUM STREET (PROPERTY ID #54646).**

WHEREAS, the City of Commerce has become an owner of certain real property described as 806 Plum Street (Property Id #54646) by virtue of the fact that a sufficient bid was not received at a Resale Auction Sale in June of 2018,

WHEREAS, because the property described is not currently on the tax roll and will not be added to the tax roll until it is sold, it is desirable that the property be sold so that it may be added to the tax roll and so that the taxes may be assessed against the property in the future;

WHEREAS, an offer has been made to purchase the property, and the City of Commerce wishes to accept the offer Joe Davis made to purchase the property known as S4380 ORIG TOWN OF COMMERCE, BLK 39, LOT 7, ACRES 0.2113, Property # 54646 for **ONE THOUSAND, THREE HUNDRED & EIGHTY DOLLARS (\$1,380.00)** and;

WHEREAS, the City Council of the City of Commerce believes a sale for this price is the best interest of the city; and

WHEREAS, the funds received pursuant to this sale shall be distributed according to the Texas Property Tax Code.

**NOW, THEREFORE, BE IT RESOLVED THAT BY THE CITY COUNCIL OF
THE CITY OF COMMERCE, TEXAS:**

SECTION 1. that the City Council of the City of Commerce hereby approves the sale for the terms stated above and authorizes the Mayor to sign the Deed on the behalf of the City of Commerce.

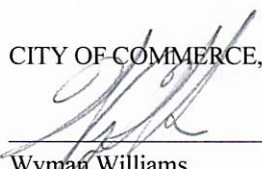
SECTION 2. this Resolution shall be in full force and effect immediately upon its passage and approval.

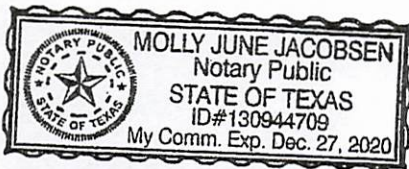
