

RESOLUTION NO. 2021 - 46

A RESOLUTION ALLOCATING THE CITY OF COMMERCE'S CHOICE OF 161 VOTES FOR NOMINEE JOHN SANDS TO BE ELECTED BY BALLOT FOR THE HUNT COUNTY APPRAISAL DISTRICT BOARD OF DIRECTORS FOR THE 2022-2023 TERM. AUTHORIZING MAYOR TO EXECUTE SAID RESOLUTION AND AUTHORIZING CITY SECRETARY TO AUTHENTICATE MAYOR'S SIGNATURE TO SAID RESOLUTION. AUTHORIZING CITY MANAGER TO EXECUTE ANY AND ALL OTHER INSTRUMENTS REQUISITE TO IMPLEMENTING SAID RESOLUTION, AND AUTHORIZING CITY SECRETARY TO AUTHENTICATE CITY MANAGER'S SIGNATURE TO ANY AND ALL OTHER INSTRUMENTS REQUISITE TO IMPLEMENTING SAID RESOLUTION.

A regular meeting of the City Council of the City of Commerce, Texas, was held in Commerce, Texas, at City Hall on the 16th day of November 2021, at 6:00 p.m.; a majority of Council Members being present and constituting a quorum, the following resolution was adopted;

WHEREAS, with the advice and consent of the City Council, Mayor Wyman Williams nominated John Sands to the Board of Directors for the Hunt County Appraisal District in September of 2021.

WHEREAS, the City Council of the City of Commerce deems it to be in the best interest and general welfare of the City of Commerce that said votes be cast in favor of the Council's Nominated Candidate.

NOW THEREFORE, BE IT RESOLVED that the City of Commerce casts its 161 votes to nominee(s) John Sands for the Board of Directors of Hunt County Appraisal District for the 2022-2023 term.

BE IT FURTHER RESOLVED that the Mayor of the City of Commerce, Texas, be authorized and he is hereby authorized to affix his signature to said resolution; that the City Secretary be authorized and she is hereby authorized to attest to signature of the Mayor to said resolution.

BE IT FURTHER RESOLVED that the City Manager of the City of Commerce, Texas, be authorized and he is hereby authorized to execute any and all instruments requisite to implementing said resolution; that the City Secretary be authorized and she is hereby authorized to attest to signature of the City Manager to any and all instruments requisite to implementing said Resolution.

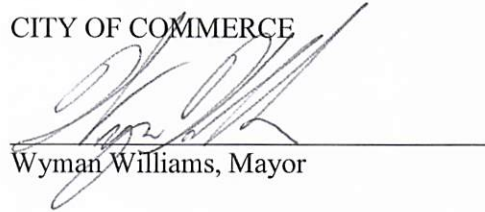

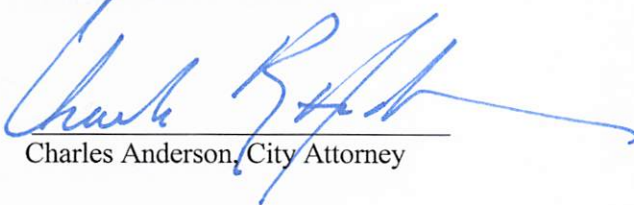
