

RESOLUTION NO. 2023 – 09 -01

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COMMERCE, TEXAS AWARDING THE CONTRACT FOR HEALTH INSURANCE BENEFITS TO ALL STATE; AWARDING THE EMPLOYEE DENTAL INSURANCE BENEFITS TO UNUM DENTAL; AWARDING THE EMPLOYEE VISION INSURANCE BENEFITS TO BLUE CROSS BLUE SHIELD OF TEXAS; AWARDING THE EMPLOYEE BENEFITS FOR LIFE/DISABILITY INSURANCE TO BLUE CROSS/DEARBORN; AWARDING A CONTRACT TO FIRST STOP HEALTH FOR MEDICAL CONSULTATION SERVICES; AWARDING A CONTRACT FOR MENTAL TELEHEALTH SERVICES TO SUPPORTLINC; AWARDING A CONTRACT TO NBS FOR COBRA, AND FOR HSA SERVICES TO OPTUM BANK; AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO TAKE ALL ACTION NECESSARY ON BEHALF OF EMPLOYEE BENEFITS TO COMPLY WITH THIS RESOLUTION FOR EXECUTION OF EMPLOYEE BENEFITS FOR FISCAL YEAR 2024; AND PROVIDING AN EFFECTIVE DATE.

A regular meeting of the City Council of the City of Commerce, Texas, was held in Commerce, Texas, at City Hall, on the 19th day of September 2023, at 6:00 p.m.; a majority of council members being present and constituting a quorum, the following resolution was adopted:

WHEREAS, the City of Commerce, Texas (the “City”) has received proposals for employee benefit rates including health insurance, dental and vision insurance, life/short and long term disability insurance, and other ancillary employee benefits and assistance services; and

WHEREAS, the City desires to award contracts for the provision of insurance benefits and other services for the use and benefit of the employees of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORNEY, TEXAS:

SECTION 1. The above and foregoing premises are true and correct and are incorporated herein and made part hereof for all purposes.

SECTION 2. That the City awards the contract for the provision of health insurance benefits to All State and awards the contract for dental insurance to Unum, the contract for vision insurance to Blue Cross Blue Shield of Texas, and life/disability insurance to Blue Cross/Dearborn.

SECTION 3. That the City award the contract for services to First Stop Health for medical consultation services, a contract to SupportLinc for mental health services, and award a contract to NBS for Cobra, and to Optum Bank for HSA services.

SECTION 4. The City Manager is hereby authorized to enter into Agreement(s) with the various providers for employee benefits and assistance services as necessary for execution of the

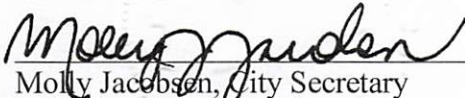
benefits.

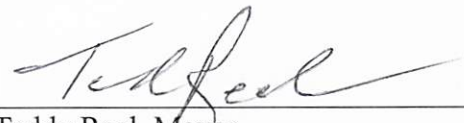
SECTION 5. This Resolution shall take effect immediately from and after its passage.

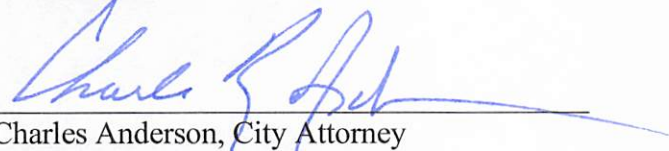
