

RESOLUTION NO. 2025 – 03 – 03

A RESOLUTION BY THE CITY COUNCIL OF THE CITY OF COMMERCE, TEXAS APPROVING THE TERMINATION OF THE SERVICE AGREEMENT WITH SCOTT, SINGLETON, FINCHER AND COMPANY PC, TO TERMINATE PREVIOUSLY ENGAGED AUDITING SERVICES TO THE CITY OF COMMERCE FOR THE PERIOD ENDING SEPTEMBER 30, 2024, AND AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO EXECUTE DOCUMENTATION RELATED TO THIS TERMINATION.

WHEREAS, the City of Commerce entered into a service agreement with Scott, Singleton, Fincher and Company PC dated December 2024 for the purpose of conducting auditing services for the City of Commerce from October 1, 2023 through September 30, 2024; and

WHEREAS, the City of Commerce has reviewed the terms and performance of the agreement and has determined that it is in the best interest of the City of Commerce to terminate the service agreement with Scott, Singleton, Fincher and Company, PC; and

WHEREAS, City Staff are authorized and directed to provide written notice to Scott, Singleton, Fincher and Company PC for the termination of the service agreement and to make any necessary arrangements for the conclusion of any ongoing services or obligations under agreement; and

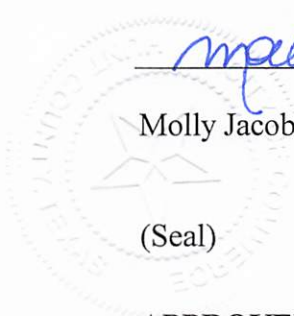
AND WHEREAS, City staff recommends the City Council authorize terminating the service agreement with Scott, Singleton, Fincher and Company PC to no longer provide the City's audit services for Fiscal Year 2024.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COMMERCE, TEXAS THAT: The City Council approves the termination of the service agreement with Scott, Singleton, Fincher and Company, PC to no longer provide auditing services for the City of Commerce for the period ending September 30, 2024 and authorizing the Mayor or his designee to execute documentation related to this agreement.

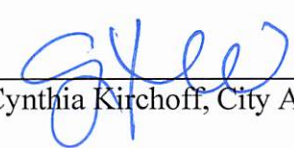
